WHEREAS, by this amendment, the Association intends to incorporate the legal description of the Maysville Meadows Subdivision as set forth on Exhibit A into the Declaration.

WHEREFORE, the following amendment is made to the Declaration:

- (1) Exhibit A, which is attached hereto and incorporated herein, shall be deemed attached to and incorporated in the Declaration for the Maysville Meadows Subdivision, as amended.
- (2) <u>Effect</u>. The Association has authorized the President to execute this Amendment, which must be attested to by the Secretary of the Association. This Amendment shall be effective as of the date recorded in the records of the Chaffee County Clerk and Recorder, and shall relate back to the recording of the Declaration. After recording of this Amendment, the Declaration, amended, shall at all times, be deemed to include Exhibit A attached hereto.
